We kindly request that you do not send a copy of the back of your credit/debit card(s).

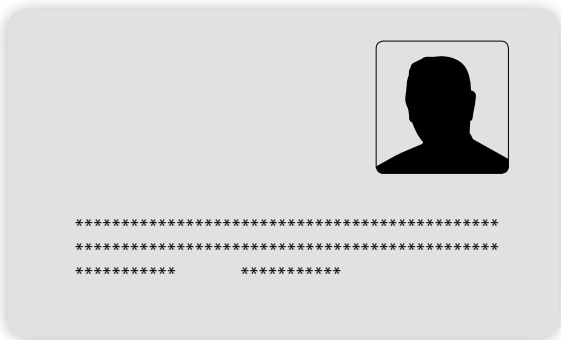

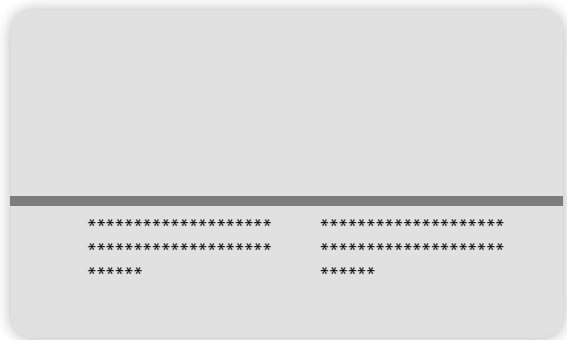
